- **3.** The poll papers, which were incomplete and/or which were otherwise found defective have been treated as invalid and kept separately.

Further to the above, we submit our report as under:

- (i) The remote E-voting period remained opened from December 23, 2022(10:00 A.M.) to December 25, 2022 (05:00 P.M.);
- (ii) The members of the Company as on the record date / cut-off date i.e. December 19, 2022, were entitled to cast their vote electronically on the resolutions as mentioned in the notice of the EGM of the members of the Company;
- (iii) In case of the selling shareholders offering shares under the offer for sale ("OFS") category, their aggregate shareholding shall remain intact and such shareholder shall be considered as one while casting votes on the shares held individually or under the company's ESCROW Account.
- (iv) The details containing *inter alia*, list of the members, who voted "for", "against" the resolution that were put to vote, were generated from the evoting website of NSDL i.e. www.evoting.nsdl.com and based on such reports generated, the result of the e-voting are as under:
